QUALIFYING PROCEDURE

Only Competitors who are entered for the Event, pass inspection and possess a current unrestricted 2026 CARS Tour Driver's License will be eligible.

Two consecutive qualifying laps. Faster lap determines qualifying position. Adjustments or repairs may not be made on the vehicle after the vehicle has taken the green flag at the start/finish line.

All cars will be impounded after Qualifying. All cars must participate in the Qualifying Procedure "RACE READY." Work will not be permitted on any car after Qualifying / before the Race with the exception of "approved adjustments" permitted by the CARS Tour Technical Director at a designated time.

STARTING POSITIONS AND **PROVISIONAL STARTING POSITIONS**

The starting field for this event will be established as follows:

Starting positions 1st through 28th will be determined by qualifying

Provisional Starting Position 29th has been established for the highest ranking of the Top 30 Car Owners in the current 2026 CARS Tour Late Model Stock Car owner point standings who has not yet qualified for the Event.

Provisional Starting Position 30th has been established for the highest ranking of the Top 30 Car Owners in the current 2026 CARS Tour Late Model Stock Car owner point standings who has not yet qualified for the Event.

If Provisional Starting Positions 29th and 30th remain unfilled, then those position(s) will become available to the next eligible car from the Qualifying Procedure

Provisional Starting Position 31st has been established for the most recent CARS Tour Late Model Stock Car Past Champion Driver who has not yet qualified for the Event. If there are no Past Champions in need of this provisional starting position, it will not be filled.

RACE RULES & FORMAT

ENTRY REGULATIONS

Entries must be filed and paid in full via the Pit Pay App. Telephone, email and/or faxed entries will not be accepted. CARS Tour is under no obligation to accept any entry. Entry / Inspection fees are non-refundable and may not be carried over to a future event.

ELIGIBILITY REQUIREMENTS

The event shall be run in accordance with all of the applicable CARS Tour Rules, the provisions of this Official Entry Blank, any special rules applicable to this event and any amendments thereto. In the event of any conflict between the Rule Book, the Official Entry Form and the special rules, CARS Tour determination as to the interpretation and application of the conflicting rules will be final. All drivers and car owners must have a valid CARS Tour License that is not currently suspended or revoked. All engine fluids,

lubricants, solvents and fuels must be disposed of in a manner in accordance with track rules and procedures and all other applicable federal, state and local laws and regulations. All cars must be inspected by CARS Tour prior to being permitted to engage in practice or time trials. Cars that have not been checked in for inspection during the inspection period may not be permitted to compete (EIRI). All cars are subject to the control of CARS Tour from the time they enter pit area until they are officially released by CARS Tour. CARS Tour is not responsible for any loss or damage to any car.

CARS TOUR TIRE RULE:

LS - Hoosier F-45*

RS – Hoosier ST3*

MAXIMUM of twelve (12) tires may be purchased for the Event. Eight (8) tires to be used for practice and four (4) tires to be used for qualifying and the race. Cars must race on the tires in which they qualified. Any tire changes during the race will result in a two (2) lap penalty unless the car enters the pits with the tire flat on the rim. The only tires that may be used during an approved change are ones that have been purchased at the track during the current Event.

OFFICIAL FUEL: “Sunoco Standard 110 Purple” is the only fuel approved for use. **Fuel used in competition must meet the same specifications as the fuel dispensed from the Official Supplier’s station at the venue.**

DISCLAIMER

To qualify entrant for driver and/or car owner CARS Tour Championship points, this entry form should be completed in full and submitted to CARS Tour in accordance with the conditions set forth in this entry form. However, any entrant who performs an act or participates in actions deemed by CARS Tour to be detrimental to the sport of auto racing or the CARS Tour, or fails to abide by the provisions of this entry form, shall be subject to loss of CARS Tour Championship points and/or fine and/or suspension.

EACH CAR MUST HAVE ONE (1) SPOTTER IN THE OFFICIAL SPOTTERS' LOCATION WITH CAPABILITY OF MONITORING CARS Tour RACE CONTROL OR CAR WILL NOT BE ALLOWED TO COMPETE.
